Space BD receives ¥100m (\$1m) seed investment to start holistic launch services for microsatellites and nanosatellites with rideshare matchup and outsourcing functions.

Space BD Inc. (AlOS Ginza 6th floor, 8-17-5 Ginza, Chuo-ku, Tokyo 104-0061 JAPAN; Co-Founder, CEO: Masatoshi Nagasaki) received ¥100 million (1 million US dollars equivalent) investment in the form of third-party allocation of shares from the 4th Incubate Fund limited partnership for investment.

This financing will be used to strengthen the holistic launch services for microsatellites and nanosatellites.

■ Use of the Fund

Space BD is the startup established on September 1st 2017 with the mission of development of space industry as a service provider which grapples with business development in the industry.

The demand of microsatellites and nanosatellites launching is increasing by technical innovation while the effort of miniaturizing the launching vehicles are not catching up with it. Given such background, the satellite launchers are seeking opportunities of rideshare with large (or main) satellites. Space BD provides such satellite launchers with holistic launch services which include not only the intermediation function between rideshare opportunities and satellite launchers, but also outsourcing services such as interfacing, safety examination, import/export, contract negotiation. We aim to contribute to create an ideal environment where satellite launchers and rocket development enterprises can focus more on their technical development. The fund will be used to strengthen our team to shape this service model.

■ About the Investor

Incubate Fund is a venture capital specialized in investing in startups in the seed stage with its mission of "First Round and Lead Position." Since the establishment in 1999, it has managed the fund worth around \$300 billion (\$300million) and invested in about 300 venture businesses through its related fund.
